
## Response

## **The false claims and intrigues of Kal K. Korff**

FIGU has been asked on several occasions what we think of Kal K. Korff and in particular of his new book 'Spaceships of the Pleiades', published in the USA (by Prometheus Books) in 1995. - Well, simply put, we think that Kal K. Korff is a fibber who has written a book that is consistent with his character.

(By using an extra-large font, Korff was able to stretch his book on the Billy Meier case to 439 pages. The acknowledgements alone require more than 10 pages. This is probably intended to give the reader the illusion of scientificity and seriousness).

Korff's book is mainly about his trip to Switzerland. Under the false name of Steve Thomas and in disguise, he visited the Semjase Silver Star Center in Schmidrüti in the summer of 1991 (accompanied by Tina Layton). On two days he had the opportunity to talk for a few hours with FIGU members. With Billy Meier himself he could not exchange a word.

Since in Korff's book almost on each page untruths and exaggerations etc. are to be found, it would go beyond the framework of this text to deal with all. By means of a few excerpts from Korff's book it shall be shown in the following exemplarily, with which deceitful statements he manipulates the readers of his book after line and thread and tries to abuse them for his lousy purposes. (Some of the following false claims of Korff are so absurd that they seem somehow funny again).

### **Korff's false claim (page 38):**

"During one of his (Billy's) supposed time-travel adventures into the past, he met Jesus Christ!  
... he is the reincarnated Jesus Christ!"

**Truth:**

Neither in writing nor verbally Billy Meier has ever claimed to have met Jesus Christ, nor to be his reincarnation! On the contrary: Billy Meier refuses vehemently and in all form against such outrageous assertions and rumors.

**Korff's false claim (page 64):**

"Although we had only walked a few hundred feet in the property, it was already o b v i o u s that Meier was anything but 'poor,' contrary to what his supporters had all been led to believe. ... After walking for about 10 minutes, we came to a brown wooden house...  
... a guest house ..."

**Truth:**

The Semjase-Silver-Star-Center does not belong to Billy Meier, but is **common property of** all FIGU-members! - By the way: With normal walking you need about **3 minutes** from the restaurant Freihof to the first house (we don't have a guest house!).

**Korff's false claim (pages 67 to 69):**

"... Down on the hillside I could see the faint remnants of three 'UFO landing rings' that had been there since at least June 1980. I remembered the pictures I had seen in (Wendelle) Steven's 'Pre- liminary Investigation Report' and Gary Kinder's 'Light Years'. Although the land tracks were 11 years old on the date of my visit, they were still just visible to me with the naked eye. ... Although my video camera has a 10x zoom, it turned out that the landmarks were too far away to see any significant details. ... incredibly, Gary Kin- der said he **never** saw land tracks during the 5 weeks he lived at Meier's place! Instead, Kinder claims that he only 'talked to various people who had seen and photographed them when they (the land tracks) were still fresh.' It is doubtful that Gary Kinder's claim is true, since the three UFO landmarks are located on Billy's property directly behind his house and below his backyard! Not only are they easily visible from numerous localities on the property, but it is actually impossible to miss them most of the time when walking back and forth between the guest house and Billy's residence."

**Truth:**

As the picture on page 65 shows (Fig. 7), the place where Menara set down her blasting ship on the meadow on June 15, 1980, has been covered by trees and bushes for years, and secondly, the landing site in question is located beyond a slight elevation in a depression and would not be visible from the forecourt near the house even if no trees and bushes were growing! Thirdly, there was nothing to be seen of the landing tracks (the depressed grass) already in 1981. - Apparently, only someone like Korff is able to see the nothing. There are only two possibilities: Either Korff had hallucinations, or he is a damned fibber. Regarding Korff's sketch of the FIGU site on page 70 (Fig. 10), it must be noted that all proportions and distances are drawn incorrectly. Either Korff is incapable of drawing such a sketch correctly, or he deliberately wants to convey a completely wrong picture of the center site to the readership.

**Korff, the 'careful' researcher (page 73):**

"... Elisabeth Gruber, the wife of Guido Moosbrugger, ..."

**Truth:**

Elisabeth Gruber is married to a Mr. Gruber, and Guido Moosbrugger's wife is named Elisabeth Moosbrugger.

**Korff's fantasy world (page 77):**

"... like the 'fact' that Billy Meier's full, true name was allegedly 'Eduard Albert Meier- Zafiriou'. A check at the local cantonal police station in Meier's region, in the village of Hinwil, showed that there is no record of Billy Meier's 'true' name containing the word 'Zafiriou'."

A footnote goes on to say, "The name 'Zafiriou' was added (to his name) by Meier in recent years when his 'mission' took on increasingly religious overtones. Zafiriou is said to be Meier's name of the prophet who reincarnated from a past life."

**Truth:**

In Switzerland, it is customary for a man to also list the name of his wife. Billy Meier's wife, a native of Greece, was called Zafiriou when she was a girl. - It's that simple!

**Korff (pages 78 ff.):**

His misrepresentations and distortions regarding the Talmud Jmmanuel.

**Truth:**

In this regard, Prof. James W. Deardorff comments in his article: " A refutation of the false claims and distortions by Korff ".

**Korff's assertion (page 95):**

"... for among Meier's believers (as well as in the pro-Meier literature) it is repeatedly told that Billy Meier was a simple peasant who was uneducated (illiterate) and had only a school education up to the 6th grade..."

**Truth:**

Billy Meier has completed the normal school workload at that time (in the 1940s) (= 8 school years = lower and middle school), and even though he lives on a farm today, he himself is not a farmer. His main occupation is the writing of books, through which he gives his self-acquired or preserved great spiritual knowledge to mankind for future use. Regarding the term 'uneducated', everyone is recommended to read Billy's book of fairy tales, for example 'The Spring Princess'.

Calling Billy Meier an 'uneducated' (read: dopey) peasant was an invention.

**Korff's false bahauptungen (pages 98 and 99):**

Korff intended to take soil samples from the land tracks in the Center area and describes this in his book as, "...I therefore decided to return to the camp (he means the Center) that night, dressed in a U.S. Army camouflage suit to minimize my visibility. As Tina and I drove back up the hill, past Meier's property, we parked our car just on the other side of the hill and then walked back down to the upper parts of the camp. For safety reasons, I made sure Tina stayed close behind me, close enough to our car so she could drive away unless I returned or was captured.

Approaching one of the electric fences, I slid quietly under it, making sure I didn't touch any of its wires. After passing under the fence, I slid down the hill and to where I saw the remains of one of the land tracks. I retrieved some plastic bottles from my carry bag and took comparison and sample soil samples. Now that I had my evidence, it was time to get out of there quickly to avoid capture. With the existence of dogs in Meier's compound, a weapons depot for use by his people when the end of the civi- sation nears, security personnel, and the fact that Meier often carries a gun himself, I was

happy not to be discovered... I then ran to our car, and Tina and I drove back ..."

**Truth:**

Anyone who is even slightly familiar with the center site can't help but laugh at the picture Korff presents.

1. A dismountable, electric pasture fence (with only 1 wire!) was only set up where the cows were grazing at the time. In addition: No passage or hiking trail is closed with a gate or fence.
2. Korff cannot have reached the place he was looking for (landing site) as he describes the route.
3. Which soil samples do you think Korff took with him to America, when he
  - a) itself was not in the right place and
  - b) from the once years ago existing land tracks (= spirally pressed down **grass!**) in 1991 with the best will nothing more was to be recognized nor found, not even in daylight?!
4. There have been no dogs at the center since the mid-1980s.
5. Regarding armory: True, we have a nice collection of pitchforks and hayforks; and if someone were to claim that we have a nuclear bomb in the basement, it would undoubtedly be believed by ge- wissen idiots. - Yes, there are rifles and handguns at the Center. All of them are registered with the authorities. Moreover, in Switzerland, the majority of the male population does military service and takes the rifle home outside of the service period or receives it as a gift as personal property after honorable discharge.
6. Just imagine the image: On a peaceful summer night, Korff runs to his car in a camouflage suit, drenched in sweat.

**Korff's false claim (page 179):**

He claims that the background on the two photos is totally different.

**Truth:**

The same snow field just to the right of the fir (in the upper picture) can be seen unmistakably 1.5 cm to the left of the fir in the lower picture!

**Korff's assertion (page 198):**

Lower picture (Fig. 66) The UFO is suspended from the suspension line.

**Question for Korff:**

Why is the 'line' bent upwards when 'a model' is supposed to hang from it?

**Korff's assertions (pages 201 to 207):**

He calls the Hasenböl-Langenberg photos a forgery.

**Truth:**

Read Prof. James W. Deardorff's opinion piece, "A Refutation of Korff's False Claims and Distortions."

For interested persons: All 34 pictures of the Hasenböl-Langenberg series are available at FIGU as posters (70x100 cm). Also for photographically educated persons the overall view of this series should be proof enough for the authenticity of the demonstration flight of a 'UFO' (Semjases jet ship) in the Zurich Oberland, Switzerland.

**Korff's imagination 'gallops' (pages 261 to 264):**

"Billy Meier says that when he was 'in space for 5 days' he was lucky enough to photograph one of God's eyes. When I read Meier's claim that he had 'photographed' God's eye in my

book of 1981, the reaction of the Meier supporters (especially Wendelle Stevens) was very strange. Not only did they deny that Billy Meier had ever said such a thing, but they ignored the fact that I had received copies of these actual photographs from Colman VonKeviczky, who had received them (in turn) from Hans Jacob."

**Truth:**

Billy Meier has photographed on his 'Great Journey' through the universe among other things the Ring Nebula in the constellation Lyra. This Ring Nebula is not of natural origin, but was created by a megalomaniac extraterrestrial and self-proclaimed 'god' who caused a whole solar system to explode. This is the reason that this nebula is called JHWHMATA (= eye of God) by the Pleiadians. If Korff had really studied the Meier literature so thoroughly, as he claims this in his book so magnanimously on page 137, he could have read the exact facts in the Semjase contact reports.

As proof of the high intelligence and serious doggedness of certain Billy Meier enemies, we don't want to withhold one last tidbit from our readers:

Guido Moosbrugger refers in his book '*... und sie fliegen doch!*' on pages 267/268 to VonKeviczky's (director of ICUFON USA) and Korff's statements on the subject 'Eye of God'. He quotes:

"Surprisingly, when asked why he had not photographed both eyes of God, he (Billy Meier) replied that this had not been possible because the latter's other eye had winked at his Pleiadian companion 'Semjase'."

As Walter H. Andrus, Jr, International Director of MUFON, says on the book jacket of Korff's 'masterpiece', "Kal Korff is to be congratulated for his determination and persistence in seeking the truth ..."

**The Jews faithful to the Torah have no part in the machinations against the Swiss**

According to the Torah, we must declare that the true Jews oppose these rebellious acts: Demands on, investigations, accusations and allegations against Switzerland (banks, government, institutions) or any nation. We will not accept any resulting funds or assets. And certainly we are against threats of boycotts, coercive tactics, name-calling and intimidation.

What we do know is that Switzerland was a safe haven during the war for thousands of Jews, including those taken in by the surrounding occupied countries, and Jews lived there in peace. Furthermore, Switzerland and Sweden provided - at great risk - safe houses in Budapest that gave shelter to 100,000 Jews.

**The Faith and Teachings of the Torah During the Exile**

We have solemnly sworn to God (G'd) "not to enter the Holy Land as a whole before the predicted time", "not to rebel against nations": to be loyal citizens, not to do anything against the will or honor of any nation, not to seek revenge, discord, redress or compensation; "not to leave the exile prematurely". On the contrary, we have to be humble and accept the yoke of exile. If we violate the oath, the result would be "Your flesh will be made a prey like the deer and the antelope in the forest", and the redemption will be delayed. (Talmud Tractate Ksubos 111). Violating the oath is not only a sin, but blasphemy, because it is against the foundations of our faith.

Before the Almighty gave us the Holy Land 3268 years ago, He set the following conditions: If we obey the Torah, it is ours; if not, we will be expelled. Unfortunately, we sinned and were expelled from the land ('Umipnay chatoenu golenu mayartsenu'). Only through complete repentance will the Almighty alone, without human effort and intervention, deliver us from exile. This will be after God sends the prophets Eliyu and Moshiach to bring all Jews to complete repentance. At that time, there will be universal peace.

Any suffering in exile is a punishment from God, and there is nothing we can do about it on our part, because the nations in which we suffered are only God's instruments against our iniquities. The Torah teaches us how to survive in exile by being humble (not resentful, demanding or vengeful). The Torah gives us an example of this, saying that one must walk in the ocean beneath the wave (Talmud Tractate Yevomos 121). We must accept the punishment; if we rebel against it, we will suffer more. The only way to alleviate suffering in exile is through repentance. We must mend our ways and pray that God will not punish us again.

For 1800 years, the Jewish people faithfully adhered to this belief and dealt with the problems of exile accordingly, never asking for things taken away from them, until the advent of Zionism 100 years ago.

**Zionist exile policy**

The Zionists do not believe that the Jews are a special nation, but they say that the Jews are a nationalistic people, a nation like all other nations, and that they can solve their problems on their own, with the slogan "Never again!". They say that we Jews were expelled because we had a weak army, and that we suffer in exile because we do not stand up physically or politically, because we do not speak loudly and shamelessly, because we allow ourselves to be trampled on and do not demand reparations. They claim that we can get ourselves out of exile with a strong army. But by the atheistic exile policy they provoked and strengthened the anti-Semitism in Europe, which led to the Second World War and the destruction of European Jewry. All the great rabbis warned about the terrible consequences of the Zionist blasphemy. The same policy of exile has had a negative impact in the Middle East, where until the rise of Zionism Jews lived peacefully with

the Arabs lived together, created the problems. Now the same tactics are being used against Switzerland and other nations.

The very act of seeking compensation and reparations from a nation - even without threats - provokes anti-Semitism, whether or not they receive what they ask for. Anti-Semitism is a phenomenon that serves the basic goals of Zionism - to increase immigration to their state. This is proven by the fact that the whole campaign against the Swiss in the Zionist state (meaning Israel; d.t.) was triggered by Avraham Burg, the head of the Jewish Agency (the Zionist organization that promotes immigration to the Zionist state).

### **Zionist Chutzpah (Impudence)**

## **Solar puzzle nears solution - thanks to data from the SOHO spacecraft**

Memo from NASA Headquarters, November 5, 1997 (Donald Savage and Bill Steigerwald).

A likely solution to one of the Sun's larger mysteries has emerged from recent observations made as part of the European Space Agency or NASA SOHO (Solar and Heliospheric Observatory) mission.

The new findings appear to be responsible for much of the energy needed to generate the high temperatures of the corona, the outermost layer of the sun's atmosphere. Since the corona temperature was first measured 55 years ago, scientists have lacked a satisfactory explanation for why this temperature is 3 million degrees, while the visible surface of the sun is only 11,000 degrees Fahrenheit, or about 6,000 degrees hot.

It is physically impossible to transfer thermal energy from the cooler surface to the much hotter corona, so the energy transfer would have to be in the form of waves or magnetic energy. To date, however, no measurement has found sufficient energy to account for the coronal temperature.

"We now have direct evidence of upward transfer of magnetic energy from the solar surface up to the corona. There is more than enough energy coming from the loops of the 'magnetic carpet' to heat the corona to its known temperature," said Dr. Alan Title of the Stanford-Lockheed Institute for Space Research, at the Lockheed Advanced Technology Center, Palo Alto, CA, who led the research. "Each one of these loops carries as much energy as a large hydroelectric plant, such as Hoover Dam, generates in a million years!"

"It appears that we are very close to an explanation of why the Sun's corona is more than 100 times hotter than the surface of the Sun - solving a 55-year-old mystery," said Dr. George Withbroe, director of the Sun-Earth Connection Program at NASA Headquarters in Washington, DC. "These results underscore the importance of long-term studies of changing conditions on the Sun, from a vantage point in space."

Energy flows from the loops when they interact, producing electrical and magnetic

'Short circuits'. The very strong electric currents in these short circuits are what set the corona to

several million degrees. Images from the 'Extreme ultraviolet Imaging Telescope' (EIT) and the 'Coronal Diagnostics Spectrometer' (CDS) at SOHO show the hot gases of the ever-changing corona responding to the magnetic fields developing on the solar surface.

Observations with SOHO's Michelson Doppler Imager (MDI) provided long-term, high-resolution, well-calibrated time-lapse movies of the magnetic fields on the Sun's visible surface or 'photosphere'. These revealed the rapidly changing constituents called by Title 'the Sun's magnetic carpet,' a spray of tens of thousands of magnetic concentrations. These concentrations have both north and south poles, which are the 'footprints' of the magnetic loops that extend into the corona.

Like field biologists who study the size and life cycles of animal herds, SOHO researchers analyzed the appearance and disappearance of a large number of the small magnetic concentrations on the solar surface. "We find that after a typical small magnetic loop emerges, it splits up (fragments) and drifts around, and then disappears in just 40 hours," Title said. "It is very difficult to understand how such short-lived effects are driven by the magnetic dynamo layer, which lies more than 100,000 miles below the surface of the Sun. This could be evidence that unknown processes are at work in or near the solar surface, persistently forming such loops across the sun.

Professor Phillip Scherrer of Stanford University is the principal investigator of MDI. MDI was built at the 'LM Technology Center' and is a project of the 'Stanford-Lockheed Institute for Space Research'.

The new observations were made with various instruments as part of SOHO, which is stationed about 900,000 miles (1.5 million kilometers) sunward of Earth in interplanetary space, where it has an unobstructed view of the Sun as well as solar wind particles blown by the Sun. SOHO is controlled from the control center at 'NASA Goddard Space Flight Center,' Greenbelt, MD. SOHO was launched from Kennedy Space Center in Florida on December 2, 1995, aboard a non-reusable Atlas IAS launch vehicle.

## **SOLAR MYSTERY NEARS SOLUTION WITH DATA FROM SOHO SPACECRAFT**

Message from NASA Headquarters, November 5, 1997 (Donald Savage and Bill Steigerwald)

A likely solution to one of the major mysteries of the Sun has emerged from recent observations with the European Space Agency/NASA Solar and Heliospheric Observatory (SOHO) mission.

The new findings seem to account for a substantial part of the energy needed to cause the very high temperature of the corona, the outermost layer of the Sun's atmosphere. Since the corona's temperature was first measured 55 years ago, scientists have lacked a satisfactory explanation for why that temperature is three million degrees while the visible surface of the Sun is only 11,000 degrees Fahrenheit or about 6,000 degrees Celsius.

It is physically impossible to transfer thermal energy from the cooler surface to the much hotter corona, so the energy transfer had to be in the form of waves or magnetic energy, but no measurement to date had found adequate energy in account for the coronal temperature.

"We now have direct evidence for the upward transfer of magnetic energy from the Sun's surface toward the corona above. There is more than enough energy coming up from the loops of the 'magnetic carpet' to heat the corona to its known temperature," said Mr. Alan Title of the Stanford-Lockheed Institute for Space Research, Lockheed Martin Advanced Technology Center, Palo Alto, CA, who led the research.

"Each one of these loops carries as much energy as a large hydroelectric plant, such as the Hoover dam, generates in about a million years!"

"We now appear to be closing in on an explanation as to why the solar corona is over 100 times hotter than the solar surface - the solution of a 55-year old puzzle," said Dr. George Withbroe, Director of the Sun-Earth Connection program at NASA Headquarters, Washington, DC. "These results underline the importance of longterm study of the changing conditions on the Sun from the superior vantage point of space."

Energy flows from the loops when they interact, producing electrical and magnetic "short circuits". The very strong electric currents in these short circuits are what heats the corona to a temperature of several million degrees. Images from the Extreme ultraviolet Imaging Telescope (EIT) and the Coronal Diagnostics Spectrometer (CDS) on SOHO show the hot gases of the ever-changing corona reacting to the evolving magnetic fields rooted in the solar surface.

The observations with SOHO's Michelson Doppler Imager (MDI) provided long-duration, highly detailed, and wellcalibrated time-lapse movies of the magnetic fields on the visible surface or "photosphere" of the Sun. These revealed the rapidly changing properties of what Title calls "the Sun's Magnetic Carpet," a sprinkling of tens-of-thousands of magnetic concentrations.

"These concentrations have both north and south magnetic poles, which are the "foot points" of magnetic loops extending into the solar corona.

Like field biologists who study the populations and life cycles of animal herds, the SOHO researchers analyzed the appearances and disappearances of large numbers of the small magnetic concentrations on the solar surface. "We find that after a typical small magnetic loop emerges, it fragments and drifts around and then disappears in only 40 hours," Title said. "It's very hard to understand how such a short-lived effect could be driven by magnetic dynamo layer that is over 100,000 miles beneath the surface of the Sun. This may be evidence that unknown processes are at work in or near the solar surface that continuously form these loops all over the Sun."

Professor Phillip Scherrer of Stanford University is the MSI Principal Investigator. MDI was built at the LM Technology Center and is a project of the Stanford-Lockheed Institute for Space Research.

The new observations were made with several instruments on SOHO, which is stationed about 900,000 miles (1.5 million kilometers) sunward of the Earth in interplanetary space, where it has an uninterrupted view of the Sun and of the solar wind particles blown from the Sun. SOHO is operated from a control center at NASA's Goddard Space Flight Center, Greenbelt, MD. SOHO was launched on Dec. 2, 1995 aboard an Atlas-IIAS expendable launch vehicle from Kennedy Space Center, FL.
